Dear Beaver Dam Water Customer:

At its Open Meeting on 03/12/2025, the Arizona Corporation Commission approved a permanent increase requested by Beaver Dam Water Company, in its application filed 03/28/2024. Per Decision #80121, the below rates and charges shall be effective for all service provided on or after 04/01/2025.

A 5/8 x 3/4-inch metered residential customer with a median usage of 1567 gallons per month, will experience an increase of \$27.42 from \$31.03 to \$58.45 per month, or 88.37 percent.

Beaver Dam Water Company, Inc. is authorized to incur long-term debt from the Water Infrastructure Finance Authority of Arizona ("WIFA"), in an amount not to exceed \$650,000, for a period up to 20 years, at an interest rate not to exceed 8.0 percent. The purpose of the WIFA loan is to fund a new well for System Two and a 275,000-gallon storage tank.
